GOVERNMENT AFFAIRS UPDATES

NSPS - EPA is now finalizing the NSPS and should release it on Feb. 3, 2015. It should be in printed form by the time EXPO starts in early March. For 60 days after that date, HPBA and others can file for a judicial review. HPBA is stilling working with EPA on the NSPS, and they are also involved with the testing procedures for using cordwood. For the latest updates on this issue, please attend the session on EXPO on Firday afternoon concerning all the government affairs issues. DOE: It looks like the DOE is still intent on controlling all gas appliances. They just came out with another ruling on banning standing pilot lights. So the HPBA is working on multiple fronts including legal, working with congress and environmental groups, and other groups. They are also looking at ways where they might come up with things that probably would fall within the DOE rules. An update on this will also be happening at EXPO to on Friday afternoon. More information concerning the DOE, please contact Ryan Carroll at carroll@hpba.org.

TAX CREDIT ISSUE: The Residential Energy Efficiency (25C), which includes a tax credit for biomass-fueled stoves did pass through Congress but only for the year 2014. So if you sold any qualified product, please pass on the information to your customers. You can still help by contacting your Representatives and Senators to try and push it to be extended this year too. Rachel can help you with contacting your Senator too, or if you more info please contact Rachel at Feinstein@hpba.org.

CSPC -Remember all gas products manufactured this year must have some type of approved barrier

installed on them, and you must make sure that the barriers are installed when you leave the house. Be warn your customers about the dangers of children touching the hot glass fronts on gas appliances. To see a video that you can order or view online, go to www.safefireplacetips.com. NFPA 211: The NFPA 211 committee has come out with their revisions for the 2016 NFPA 211. Go to www.nfpa.org/211next to check out the revisions. Scroll down to "First Draft Ballot". Be sure to check out the revisions for Sections 3, 6, 11, 12, & 13. Those are the revisions that HPBA are concerned about. MAKE YOUR VOICE HEARD: HPBA has gone live with its Legislative Action Center (LAC) program, an online tool that links you directly to members of Congress. LOCAL ISSUES: Maricopa County will be issuing no burn day warnings in the coming months. Maricopa county did not fail any EPA levels around Christmas and New Years this year. Even though this is not in Arizona, another state, Utah is trying to ban all wood burning from Nov.thru Mar. in all their Northern counties.
